In correspondence and agreements drafted in the national languages, the signatory name of the Bank of Finland should be written in the form of Suomen Pankki in Finnish or Finlands Bank in Swedish. For correspondence and official documents in other languages, the correct signatory name is Suomen Pankki–Finlands Bank.
